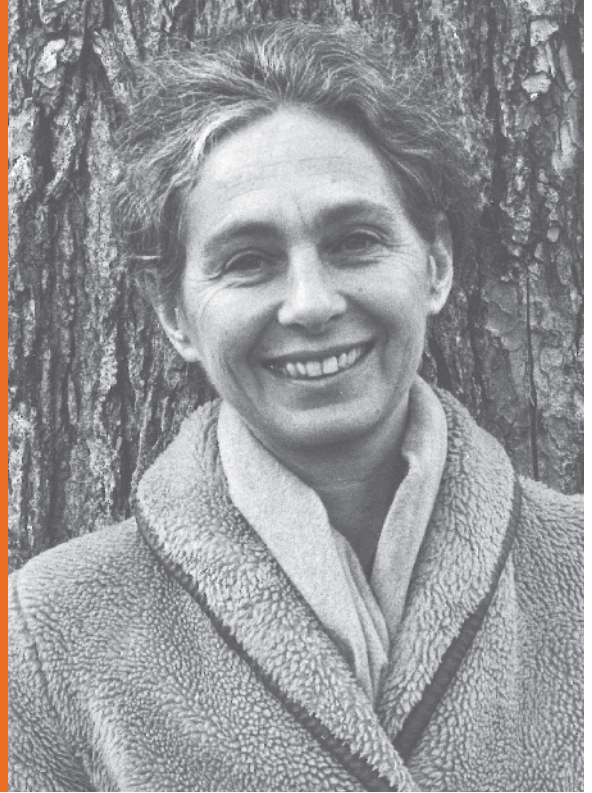


A DONOR'S LASTING GIFT TO CHICAGO

Joan Novick was a longtime Hyde Park resident and a pioneer in advertising. Joan deeply loved Chicago and decided that making a generous gift to the Trust's endowment was the best way to continue to impact the lives of her fellow Chicagoans.

While Joan had many causes that were dear to her heart, she decided that an unrestricted gift would allow the Trust maximum flexibility to meet the needs of future generations. When she died on September 25, 2022, Joan made the Trust the sole beneficiary of her estate with a gift of approximately \$2.2 million.

By entrusting her legacy to the Trust's stewardship, Joan ensured that nonprofits in the city she called home for over 50 years will be able to support their communities for years to come.



A STEADY IMPACT ON CHICAGO'S NONPROFITS

Thanks to the generosity of the Trust's legacy donors, in fiscal year 2022 the Trust was able to make \$33 million in discretionary grants to Chicago-area nonprofits serving a wide range of communities and purposes. Endowment funds are prudently managed with the goal of growing the principal to increase community grant making annually.

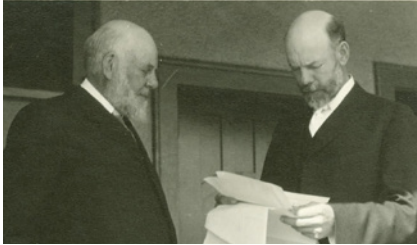

100+ YEARS OF PARTNERING WITH DONORS TO BUILD A MORE VITAL AND VIBRANT CHICAGO REGION



1915

The Harris family of Harris Bank makes a visionary gift of \$200,000 to found the Trust.

1916

Through the Harris family's investment, the Trust makes its first grant—a \$5,000 award to United Charities of Chicago.

1924

James A. Patten gives the Trust its first significant bequest—shares of stock and a parcel of land at the northwest corner of Michigan Avenue and Monroe Street on which stands the University Club, for whom the Trust continues to act as landlord.



1932

The Trust is tapped to spearhead relief campaigns raising millions of dollars for Chicagoans in need during the Great Depression.

1964

Pharmaceutical executive John G. Searle makes the single largest gift in the Trust's history, fueling decades of groundbreaking investments in biological science, health, education, and more.



The Trust granted \$250,000—nearly \$2 million today—to the Chicago Horticultural Society to develop the Chicago Botanic Garden on a 300-acre tract of land at the northern edge of Cook County. Philanthropist Mary Runnells partnered with the Trust to help fund the development of the garden both during her life and through her estate.



1984

Suburban teacher Kathleen Busse honors her late husband with a seed gift establishing

the Trust's Basic Human Needs Program.



2008

The Trust launches Unity Fund as a vehicle for donors to support the critical needs of fellow Chicagoans during the Great Recession. Our donors' generosity to Unity Fund continues to this day.

2015

We celebrate a century of impact, including \$2 billion in grants to Chicago nonprofits over our first 100 years. Marshall Field V leads local philanthropists in making legacy commitments to the Trust's endowment so we can build an even stronger region over our next 100 years.
